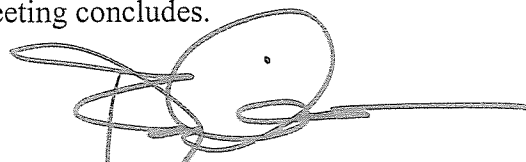

HOW TO: PARTICIPATE IN TOWN MEETING

☞ Be Recognized to Speak by the Moderator

Raise your hand, shout out “Mr. Moderator” to get the Moderator’s attention. Unless there’s a motion to cut off debate, everyone who wishes to speak will be given an opportunity at least once

☞ Go to the Microphone or Speak **LOUDLY** from your Seat While Standing

You can’t persuade your fellow voters to vote your way if they can’t hear you. Speak up and be heard. If you plan to be a frequent speaker, please sit next to a microphone to save time after you are recognized—your fellow voters will appreciate you more

☞ State Your Name and Street

There is no anonymous debate at Town Meeting. Please state your name and what street you live on. There is no need to give the specific street number or address. If you are a frequent speaker, I will try to call you by name to dispense with the introduction each time.

☞ Direct Your Remarks to the Moderator and Keep It Civil

This requires some getting used to, but you speak to the crowd via the Moderator. Instead of “John, I disagree with you” it’s “Mr. Moderator, I disagree with John.” **NEVER** engage in insult or personal attack. Remember, your opponent on this article may be your supporter five articles later

☞ It’s OK to Debate!!

The purpose of Town Meeting is to decide by majority or 2/3 vote. It’s OK to urge (via your remarks to the Moderator) your fellow voters to vote for or against something and to tell them why they should vote your way

☞ Be Brief and Confine Your Remarks to the Issue Being Debated

Please make your points concisely and then sit down. If you speak longer than five minutes, I will ask you to wrap up your remarks to give someone else a turn. I will then give you another chance to speak after others have spoken unless debate is cut off

☞ Town Meeting is Not Designed for One on One Conversations

If you have the floor, you are the only person who can speak unless asked to conclude by the Moderator or someone else is recognized by the Moderator. If you use your time to ask questions, I might not immediately call the person who can give the answers but I will get to them if they ask to be recognized. The dynamics of a mass meeting make it difficult to facilitate a back and forth dialogue between two people and it’s not fair to others who wish to speak

☞ Listen Carefully to Other Speakers

There is no need to repeat points already made by other speakers. Please listen to others with the same courtesy you would want them to give to your remarks.

HOW TO: AMEND AN ARTICLE

- ☞ After Being Recognized by the Moderator, Move to Amend the Article
This is as simple as stating “Mr. Moderator, I move to amend article X by adding/deleting the following language” and then describe your suggested changes by reference to the article under debate. If someone seconds your motion (“I second the motion”) the motion is before the Town Meeting for debate
- ☞ Give the Moderator a Written Copy of Your Motion to Amend
Unless otherwise allowed by the Moderator, all motions must be in writing. The Moderator has motion forms on the stage by his podium for ease of use, so feel free to take a form and write your motion. To save time, try to have your motion written before the debate on the issue begins. An example of the amendment form is on the next page.
- ☞ After the Moderator Reads Your Motion to Town Meeting, Explain What the Motion Does and Why People Should Vote in Favor of the Motion
After the Moderator reads your motion to the audience, you will be recognized to speak in support of your motion. This is your best chance to win support for your proposed changes
- ☞ Minor Amendments Can Be Accepted as “Friendly Amendments” Without Debate
If you are making a minor suggestion, the proposer of the original article can accept your amendment as “friendly” to accept the change without debate. The article with the friendly amendment is then subject to further debate as amended. The Moderator will only allow minor changes and only if the amendments are not so numerous that voter confusion might result
- ☞ It’s OK to Amend an Amendment
If an amendment is pending debate at Town Meeting, it’s OK for someone to move to amend the amendment. Only one amendment of an amendment will be accepted by the Moderator at a time. If amendments are adopted by majority vote, the article as amended will then be debated and voted
- ☞ An Amendment Cannot Exceed the Scope of the Original Article Proposal
There are some legal limits to amendments that the Moderator will consider when deciding whether to accept an amendment for debate. Generally speaking, an amendment cannot broaden the subject matter of an article under debate. For example, an amendment cannot add land subject to a proposed zoning change beyond the land described in the original article.
- ☞ When in Doubt, Ask the Moderator
If you’re not sure how to change an article, just ask the Moderator for procedural guidance. The Moderator will tell you what procedures are available to you to hopefully accomplish your goal.

HOW TO: CUT OFF DEBATE

- ☞ Be Recognized by the Moderator
A motion to cut off debate is not proper unless the person making the motion has been recognized by the Moderator and has the floor. A motion to cut off debate cannot interrupt another person who already has the floor.

- ☞ The Moderator Has Sole Discretion Whether to Recognize a Motion to Cut Off Debate
If a large number of people wish to speak for the first time, or if only one side of the debate has been presented, or if the person moving to cut off debate has just spoken on the merits of an article, the Moderator likely will refuse to accept a motion to cut off debate. Even if the Moderator has refused to cut off debate, the motion can be repeated after additional debate has occurred or if the debate has seemed to run its course

- ☞ After Being Recognized, State “Mr. Moderator, I Move to Cut Off Debate”
If the motion is seconded, the Moderator will immediately call for a vote by voice, show of hands or standing, and then declare whether the necessary 2/3 support for the motion has been achieved.

- ☞ On Request of Seven Voters, the Moderator Will Order a Counted Vote
If you disagree with the Moderator’s announcement of the vote results, you should stand and state “Mr. Moderator, I request a counted vote.” If six other people stand to support your request, the Moderator will order the counters to count the vote and report the results.

- ☞ If a Motion to Cut Off Debate Fails, Debate Continues
After the debate has run its course, or if the same people are speaking repeatedly, the Moderator will consider a renewed motion to cut off debate if a voter makes the motion after being recognized.

HOW TO: VOTE

☞ Voice Vote

This is the usual method of voting. After debate is concluded, the Moderator will repeat the issue that is about to be voted on, explain whether a majority or 2/3 vote is required, and then state "All in favor say aye." If you support the article, state "aye". The Moderator will then state "All opposed say nay." If you oppose the article, state "nay." The Moderator will then announce the results of the vote. Even if a 2/3 vote is required, the Moderator can announce a 2/3 vote based on a voice vote unless 7 voters request a counted vote.

☞ Show of Hands

Sometimes, the Moderator will not be able to tell which side prevailed by a voice vote or will decide in the first instance to request a show of hands. The Moderator will state "All in favor raise your hand." If you favor the article, raise your hand and keep it up until the Moderator tells you to put your hand down or calls for a vote by those opposed. The Moderator will then state "All opposed raise your hand." If you oppose the article, raise your hand and keep it up until the Moderator tells you to put your hand down or announces the vote results.

☞ Standing Vote

If it's a close vote or a counted vote, the Moderator will ask all in favor to stand. If you favor the article, stand until the Moderator asks you to sit down. The Moderator will then ask all opposed to stand. If you oppose the article, please stand until the Moderator asks you to sit down.

☞ Counted Vote

Any voter who disagrees with the Moderator's announced vote can immediately stand and state "Mr. Moderator, I request a counted vote." The Moderator will then ask "Are there six people who will stand to join you in that request?" If a total of 7 voters stand to request a counted vote, the Moderator will ask the sworn counters to conduct a counted vote by either a show of hands or a standing vote. If fewer than 7 voters join the request for a counted vote, the request fails and the previously announced vote is the official result.
